CONDITIONS OF ENTRY

1. The Championships will be conducted under Australian Billiards and Snooker Council Championship Playing Conditions, and all matters pertaining to Players' Code of Conduct will be adhered to.
2. Nominees must be a financial member of an affiliate of the Australian Billiards and Snooker Council with a date of birth on or after 1/1/1995.
3. Entrants must be an Australian citizen, and not represented another country in International competition for a minimum of 3 years.
4. Entries will only be received on the official entry form and must include the entry fee. A completed entry form and entry fee will be required before any player is permitted to compete.
5. The format of the Championships will be round robin with players progressing to a seeded knockout draw.
6. Tournament standard dress is required: Long sleeve predominately plain coloured shirts buttoned at the wrist, dress trousers, bow ties and dark colour dress shoes must be worn for all matches, waistcoat is required from the quarter finals onwards. Failure to comply with this condition will result in forfeiture of the match.
7. All players are to report to the Tournament Director 15 minutes before their scheduled starting time, and are to be ready to play at this time. Play will commence at 9.00am each day. Any player not in attendance at the schedule starting time will forfeit one frame. After a further 15 minutes has lapsed, the absent player will forfeit the game. This also applies to players not correctly attired at the starting time.
8. The winner of this Championship will be selected to represent Australia in the 2016 IBSF World Under 21 Snooker Championship & IBSF World Under 21 Billiards Championships
9. This entry form constitutes part of the conditions of entry. Changes may be made at the discretion of the Tournament Director.
10. Players may be subjected to Drug testing in accordance with the ABSC Drugs in Sport Policy.
